

Run for the Fallen event to honor GRIC veterans

Posthumous awards and recognition for Mathew B. Juan will also take place

St. Peter Indian Mission School's Run for the Fallen returns at 10 a.m. on Friday, Oct. 27, at the school's campus in Bapchule. The annual event honors Gila River Indian Community members who served in the United States armed forces and were killed in combat.

This event will pay special tribute to Mathew B. Juan, the first Native American and first Arizonan to be killed in action. He will be posthumously awarded the Citation Star, Silver Star Medal and Purple Heart Medal for heroism, gallantry and making the ultimate sacrifice during World War I in the Battle of Cantigny in France on May 28, 1918.

The Silver Star medal is the third-highest military combat decoration awarded for courageousness in battle and the Purple Heart is awarded to those wounded or killed during combat. The Citation Star ribbon was established in July 1918 and was replaced by the Silver Star in 1932.

Juan's early life exemplifies his adventuresome nature. In a 1941 article in Arizona Highways, his brother, Antonio B. Juan, said Mathew was a baseball star whose "chief delight was performing in the annual Sacaton rodeo," and he won prizes regularly in calf-roping. As a teenager, Juan went to Phoenix to see a circus and immediately got a job and traveled with it throughout the Southwest. In 1917, he joined the United States Army under the last name 'Rivers;' it is believed that he changed his last name and claimed he was old enough to enlist.

Shortly after intensive training, Juan was sent to New Jersey where he boarded the S.S. Tuscania, a luxury ship that had been converted to transport troops bound for Europe.

On Feb. 5, 1918, the liner carrying over 2,000 troops was torpedoed by a German U-boat resulting in the loss of more than 200 lives. Juan survived the strike and was rescued.

Juan was assigned to the 28th Infantry regiment of the Army's First Division. On May 28, 1918, the troops attacked a German-held French village called Cantigny 70 miles north of Paris. He was killed by machine gun fire during the battle.

Although Juan was buried in France with full military honors in 1921, his family requested that he be brought back home to the Community and laid to rest in Sacaton. More than 1,000 people attended the ceremony.

Juan has been recognized throughout the years since his death. In 1928, the veteran's park in Sacaton was named and dedicated in his honor and is now

known as the Mathew B. Juan – Ira H. Hayes Veteran's Memorial Park.

Native Americans have the longest history of serving in the U.S. military in every major conflict and in greater numbers than any other demographic, even though they were not granted U.S. citizenship until 1924.

Tribal Broadband Summit held in GRIC

The National Tribal Telecommunications Association (NTTA) hosted their annual Tribal Broadband Summit from Aug. 28-30 at the Gila River Resorts & Casinos – Wild Horse Pass.

NTTA provides a forum for tribally owned companies and those who work in the telecommunications industry, to share knowledge and opportunities, discuss effects on regulations, and address issues affecting tribal telcos and customers on tribal lands. "We're here to help other tribes who are new to the telecommunications and broadband world to obtain funding, plan, engineer and design their broadband infrastructure and get it deployed and get their people connected," said Duncan Wiston, Director of Community Affairs and Business Development for Gila River Telecommunications Inc.

Gila River Telecommunications Inc. (GRTI) began in 1988, initially providing telephone services to the Gila River Indian Community, but has since grown to become a leader in tribal broadband, providing internet and cellular services.

GRTI also includes its affiliates: Native Technology Solutions, Gila River Broadcasting Corporation, Alluvion Communications, and Digital Connect Initiative.



"Our goal here is to share our knowledge and expertise with newer tribes and tell them what has worked for us, what hasn't worked, and there's a lot of funding out there available on the federal and state side," Wiston said.

GRTI is a member of NTTA and has hosted the tribal broadband boot camp and summit for three years, held in Gila River due

Evelyn Enos is a member of the Gila River Indian Community - District 4 and now serves as a 2023-2024 Earth Ambassador for United National Indian Tribal Youth, UNITY Inc. (UNITY). She currently attends Arizona State University (ASU), majoring in biological sciences (neurobiology, physiology, and behavior) with a minor in American Indian Studies.

In celebration of Earth Day - April 22, Enos and nine other Indigenous youth throughout the U.S. were selected and announced as UNITY 2023-2024 Earth Ambassadors.

Earth Ambassadors serve as environmental stewards and leaders to fellow Indigenous youth by increasing awareness and engagement on issues affecting tribal lands and promote efforts to address environmental concerns.

"It was a really competitive selection process," said Enos, who applied for the stewardship along with several other applicants who must present a platform as part of the application process.

"My platform is to promote ancestral environmental aware-

ness through a camp hosted within water policies, the fight to regain the Gila River Indian Community," said Enos, "I wanted to use sites like MAR 5 to host workshops or like even a day camp."

fer Recharge site (MAR 5) interpretive trail serves as an outdoor educational center open to Community members and the public, offering a live look at traditional plants and wildlife that flourished from the Gila River.

Enos has begun working with the Community's Department of Environmental Quality (DEQ) and ASU to assist in gathering resources needed for such a workshop or camp.

While growing up, Enos recalls many of her summers spent in the Community with her grandparents, learning about GRIC's those rights, and the annual Water Rights Day celebration held on Dec. 10.

"It became apparent that I Gila River's Managed Aqui- need to protect my himdag and know what I'm doing, so that when I go on in life that I'm able to continue these traditions with the resources that we have, that we've always had," Enos said.

> She became more environmentally aware by cultivating a garden of her own - mostly growing zucchini and eventually raising chickens for both meat and eggs, which she also distributes to other Community members.

> "Now I'm in an Earth Ambassador role and getting to teach different things to students who are willing to learn and who want to make a difference is really exciting," she said.

> During the National UNITY conference held June 30 - July 3 in Washington, Enos and fellow Earth Ambassador Sumaya Quitugua, Acoma Pueblo, hosted "Indigenous Youth Perspective," a workshop that highlighted environmental issues youth face today and what they can do to help.

> "I just want youth to get involved and know that they can have an impact in their environment no matter what they do, little or small," said Enos. "I think that's super important to remember that our natural resources, we had to fight for them, we had to fight to get them back and protecting them is really important to protect our livelihoods."







out GRIC in achieving their goals and objectives.

"The purpose of the meet and greet today is to be able to share all the sections within OCM with all the departments and employees so that they know our resources are available to them," said Michael Preston, Assistant Community Manager.

Preston also shared that another reason behind this meet and greet was that many departments would be given a survey after using OCM services and would ask who was helping them through their service requests, often attempting to thank them. This event offered that opportunity for The sections that make up OCM range from program evaluators, Ombudsman, Community managers, contracts and grants department, data analysts, admin support, and mobile support specialists.

Each OCM section featured informational displays that showcased staff members with unique storyboards and photos highlighting their work and how it contributes to OCM overall.

One example was from Program Evaluator Sandra Walker, who is from the island of Jamaica. Walker shared that her OCM tasks consist of collecting and analyzing data within the Community and GRIC de-

to the continued growth of participants.

Tribal nations often face a digital divide and are the most expensive to build out and deploy broadband for many reasons, "Our homes aren't traditionally in subdivisions. We have scattered housing, and we're very rural," shared Wiston

Last year, the Gila River Indian Community received \$4.4 million to expand broadband connections as part of the Tribal Broadband Connectivity Program.

The Tribal Broadband Connectivity Program

makes \$980 million available for grants to eligible Native American, Alaska Native, and Native Hawaiian entities for broadband deployment, digital inclusion, workforce development, telehealth, and distance learning.

While the funding is now available, many tribes lack the ability to sustain service, "this event kind of helps them understand how these broadband networks work, but also how to build them, how to make sure that they are staying within the norms of what ISP (internet service provider) companies should look like," said Godfrey Enjady, President for NTTA.

Rez Streetwear attracts mass appeal among Native youth

Susanna Osife, District 2: Hashan Kehk, has already built her resume with a strong standing in the Community and has now ventured out to explore the world of fashion and design. Beginning in May 2023, Osife launched Rez Streetwear. This unique Indigenous-based fashion line reflects the rich culture found within the Gila River Indian Community.

Many might remember Osife as the 2019-20 Jr. Miss Gila River or as the 33rd President of the Akimel O'odham/ Pee-Posh Youth Council (AOPPYC). Years later, Osife can add entrepreneur to her resume as she begins her journey as the brand owner of Rez Streetwear.

"Early on during the pandemic, everyone was inside and there's only so much you could do on the computer, so I found my own new hobbies," said Osife. One of her new hobbies was crafting, which sparked the idea of Rez Streetwear.

The idea of a streetwear brand lived in Osife's mind for months, and she often talked openly about starting a brand. Like many first-time entrepreneurs, she faced her doubts and hesitations until her mother asked, "What are you doing about this idea and what are you doing to achieve it?" Osife said that from that point on, she devoted herself to developing the idea and launching the brand.

In 2022, Osife created her first pre-Rez Streetwear piece for herself using heat transfer vinyl. Utilizing one of her favorite accessories, Osife pressed the text "It's a good day to be Indigenous" on the side of a canvas tote bag. Then, in October, she received numerous compliments and inquiries about the bag while attending the Phoenix Indigenous Peoples' Day celebration. The interest boosted Osife's confidence to pursue what would officially become Rez Streetwear.

Eventually, after her due diligence, she purchased equipment to produce her first items. Because she creates everything herself from home, she is conscious of what she could start with.

anyone wanted to purchase one. During the O'otham New Year Celebration in June, Osife sold several bags to members of the AOPPYC who were in attendance. Little did she realize the bags would cause a splash when AOPPYC members used them at the 2023 United National Indian Tribal Youth, UNITY Inc. (UNITY) conference in Washington, D.C.

The youth in attendance expressed great interest in the bags. UNITY organizers even featured a photo of the bag on their Instagram page.

Osife was elated when she started receiving orders from Minnesota, Louisiana, Washington, and more states nationwide.

As she embarks on this exciting chapter, her Community remains close to her and is overwhelmed with how much support she's received from Community members.

Another highlight for Osife was receiving the "Female of the Year" award from the AOPPYC at this year's youth conference.

Currently, Rez Streetwear offers two original tote bags for sale. One features her original design with the "It's a good day to be Indigenous" text. The second features the word "Indigenous," repeated similar to a "Thank you" bag found in grocery stores, with the phrase "Stay Deadly" at the bottom.

Soon, Osife will be debuting more items for sale including shirts, jeans, and other fashion accessories. She cites Steven Paul Judd, Kiowa-Choctaw, the NTVS brand, and local GRIC artists as major inspirations for her.

While she didn't give details about future items and designs, she maintains that all her items are rooted in the O'otham and Pee Posh cultures. She said that in the future, one can expect to see traditional and modern O'otham designs stylishly infused with contemporary patterns on Rez Streetwear clothing.

As we await to see what comes next for Rez Streetwear, Osife drew a distinction from the Rez Streetwear fashion line and overarching aspirations of starting the "Rez Street" enterprise.

In the future, using the Rez Street name, Osife aspires to organize community events, hold concerts, curate art spaces, and more. It's a work in progress, but Osife already has the vision of Rez Street and is learning from the Rez Streetwear experience to support her larger goals.

The Arizona Department of Transportation (ADOT), in cooperation with Pinal County, will be preparing the North-South Corridor (NSCS) Design Concept Report (DCR) Tier 2 Environmental Study from US 60 to Arizona Farms Road (Segment 1) known as NSCS Segment 1. This study will:

- Narrow the selected 1,500-foot corridor to a proposed 400-foot freeway alignment.
- Identify environmental considerations and mitigation efforts.
- Identify interchange locations and design concepts.
- Develop other design features.

North-South Segment 1 study area spans approximately 20 miles and extends from the town of Florence in the south to Apache Junction in the north. The study team will further evaluate NSCS Segment 1 to identify a preferred North-South alternative, which would include the alignment, interchange locations and other design features, and evaluate associated environmental impacts and mitigation.




