Additionally, the publisher reserves the right to reject or cancel any advertisement or contract at any time.
- Advertiser agrees to indemnify and hold the Gila River Indian Community and its employees harmless from and against all claims, liabilities or damages arising from any advertisements submitted pursuant to this contract and any costs and legal fees relating thereto.
