# George Webb Village Opens; **Housing Construction** Ramps Up in GRIC

The George Webb Village has its first resident.

"I am extremely excited," said Trina Hart, great granddaughter of the neighborhood's namesake, "but I am very humbled. This is the land that my mom and my family played on, lived on, grew up on."

Hart has been on the tribal housing waiting list since 2003. She moved into her new house last month after a ribbon cutting ceremony, which took place on seven districts. her new driveway, to open the everyone involved in making her new home a reality.



#### PROBATE CODE

The Legislative Standing Committee will be considering a revision to the Probate Code at their regularly scheduled meeting on Tuesday, June 23, 2015 at 1:00 p.m., located in Conference Room B of the Community Council Secretary's Office. A copy of the proposed revised ordinance in its entirety is available for review at all District Service Centers and the Community Council Secretary's Office.

The Current Probate Code was last amended in 1985 and currently conflicts with federal law. The Draft Probate Code will provide a statutory means for adjudicating probate estates within the Community. The Draft Probate Code also provides the Community Court jurisdiction to probate real and personal property that is not considered federal trust

#### Page 1 Sample of the Code

#### CHAPTER 1. GENERAL PROVISIONS

#### 10.101. Scope and Purpose; Legislative Intent.

- Legislative Intent. The Gila River Indian Community ("Community") enacts this title under its inherent civil legislative, adjudicative, and regulatory authority pursuant to the express delegation of authority by Congress under the Indian Reorganization Act, 25 U.S.C. § 461 et seq., which provided the Community authority to organize, adopt the Gila River Indian Community Constitution and Bylaws of the Gila River Indian Community (1960) and enact ordinances governing conduct within the exterior boundaries of the Gila River Indian Reservation, 25 U.S.C. § 476. The Community enacts this title pursuant to Article XV, Section (a)(13) of the Community Constitution, as the Community has the authority to administer all Community property. Further, under Article XV, Section (b)(5) of the Community Constitution, the Community may regulate the use and disposition of property of members, insofar as such use and disposition affects the welfare of the Community at large
- The Community Council enacts this title to provide a statutory means for probating estates in the Community Court. Pursuant to the inherent powers of the Community to exercise civil authority over the probate of applicable trust property and non-trust property within the exterior boundaries of the Gila River Indian Reservation, the Community Council enacts this title to authorize and direct the Community Court to hear and determine probate roceedings to simplify the probate process, as well as, encourage tribal members to plan for the transfer of their property upon their deaths.
- C. The Community Council finds that the probate of Community member's applicable trust property and non-trust property, to include non-Community members where appropriate, has a direct effect on the health and welfare of the Community and its members. The Community enacts this title to regulate certain activities within the Gila River Indian servation in accordance with Montana v. United States, 450 U.S. 544 (1981).

#### 10.102. Evidence of Death or Status

In addition to the Gila River Indian Community Rules of Evidence, the following rules relating to a determination of death apply:

- A certified copy of a death certificate is required to probate the decedent's estate
- An individual is presumed to be dead whose death is not established under the preceding paragraph who is absent for a continuous period of not less than six years, during which he has not been in contact with those who knew him.

#### 10.103. Definitions

In this title, the following words and terms shall have the meaning given herein:

## Page 1 Sample of the Code

## 17.1001. Findings, Purpose, and Applicability.

- The Gila River Indian Community has inherent sovereignty to exercise civil authority and jurisdiction over the conduct of Community members and all other persons on all lands within the exterior boundaries of the Gila River Indian servation to maintain the environment, natural resources, pr welfare, political integrity, and economic security of the Community.
- The intent of this chapter is to exercise the Community's civil jurisdiction to the maximum extent permitted under Montana v. United States, 450 U.S. 544 (1981) to regulate activities of Indians and non-Indians on matters that threaten or affect the health, safety and welfare of the Community, its people, its property and its
- This chapter is created to provide minimum standards for the protection of the health and welfare of the people of the Gila River Indian Community and non-members, and to prevent the creation or maintenance of unhealthful, unsanitary conditions or public health nuisances, and shall be liberally construed to accomplish these purposes.
- This chapter applies to all public and semi-public bathing places which reside within the jurisdictional boundaries of the Gila River Indian Community.
- Section 17.1028 of this Code applies to natural and semi-artificial bathing places and artificial bathing lakes.
  - This chapter does not apply to any of the following:
  - A private residential swimming pool or spa;
  - A swimming pool or spa used for medical treatment or physical therapy and supervised by licensed medical personnel;
  - A Splash Pad that utilizes potable water and does not have a recirculation system.

### 17.1002. Preservation of Sovereign Immunity.

Nothing in this chapter shall be interpreted or construed as consent by the Gila River Indian Reservation, its sub-organizations, or any agent thereof to be sued in any court. This chapter is not a waiver of the Gila River Indian Community's sovereign immunity or consent to be sued for any purpose.

the Community and you can't do that without communicating."

Monthly COMPSTAT meetings held at service centers in each of the districts have been beneficial to the Community because people are attending and sharing their concerns for what they see in their neighborhoods.

Chief Elliot welcomes Community members sharing their concerns after the meeting because, he said, "We don't want people to be victims or live in fear of crimes in [their] area."

Soto, talked about the allocation of officers to areas that show higher rates of crime. He said, "We mitigate where the high crimes are at such as 'hot spots' because it helps profile certain areas."

The plan isn't to simply patrol the area and see if something happens, but to be more proactive giving the patrol officers an extra sense of awareness about certain areas.

Soto said GRPD data analysts "look at all the data, look at calls for service and the reports written by officers and discuss how to approach certain areas of high crime."

Going beyond officer patrols, the motor team and traffic team have benefited from the COMPSTAT data on traffic stops and accidents stemming from a number of causes.

The goal is to bring down the number of fatalities and offenses related to driving under the influence and let people know that drunk driving isn't something to be taken lightly as the enforcement of laws gets stiffer.

GRPD expects arrests to go up, but Soto emphasized that it would be the result of effective police work at targeting higher and lower level crimes.

A part of that includes changing the perspectives of the Community about crimes, letting them know they have an involvement in fighting crime.

Soto described and in which the districts coordinated with the GRPD to remove rowdy residents from a home.

The result, Soto said, is people "like to see the numbers and also exchange information with the police department. A lot of people want to talk about [it]," because residents make the connections about suspicious activity in their neighborhood.

Ideas like a website that provides real-time information on what is going on throughout the reservation is something Chief Elliot said, "Is part of the flow of information back and forth to Community members."

The COMPSTAT meetings will continue throughout the year, cycling through the districts.

"The feedback has been positive and informational, because they are happy to hear what is going on and what [we] have been doing," said Chief Elliot.

- 5. Set your thermostat to 78 degrees Fahrenheit when you are home and 85 degrees when you are away.



Gila River's Early Education Child Care Center is shining brighter this year after receiving four stars from Arizona First Things First.

Five children from EECC, along with EECC program manager Melissa Madrid, and First Things First regional director, Cathy Brown presented the stars in front of tribal leadership at the May 20 Council meeting highlighting the program's big accomplishment.

In 2010, Gila River partnered with the First Things First program to improve the quality of childcare services for children ages 0-5 in the Community. EECC is the first children's center to receive a four star rating in the Community and

is one of two tribally run programs to receive four stars in Arizona. There are additional Quality First sites in the Community which include Blackwater Community Day School which received three stars, Sacaton Elementary, and D3 Head Start (not yet rated).

The First Things First program is a statewide organization that partners with childhood providers and funds early education and health programs to help children become successful once they enter kindergarten. The Quality First Star Rating identifies quality levels of early childhood care and education in young children. Programs are given ratings ranging from 1 – 5 based on an assessment which focuses on adult-child interactions, learning environments and staff qualifications.

rative effort from ASU's Center for Indian Education and the Gila River Indian Community.

The eleven candidates chosen for the program are from GRIC, the Tohono O'odham Nation, Navajo Nation and the Colorado River Indian Tribes, but all work for Gila River in the field of early education. Chadwick, too, used to work in the Community as a kindergarten teacher at the Sacaton Elementary School during the mid-1990s.

The cohort of students met for classes on the Gila River reservation while also working as educators in early education classrooms over the past few years.

Graduate Amanda Beeson, a member of CRIT, said, "We learned about how to develop a curriculum and effectively apply classroom management skills."

The District 6 Head Start Teaching Assistant said the biggest benefit came from being in a classroom with co-workers and people they knew that worked in the Community.

For Community member Anna Edwards, the opportunity to get a college degree was too good to pass up.

"[It] was really good because there was always someone to help us along and that was one of the amazing things about the cohort. We

supported each other," she said. Edwards is a Mentor Teacher at GRIC Early Childcare.

She said at her job, "Now...I have a chance to share with them what I was able to learn from the program." She plans on possibly starting within a year to obtain her Masters Degree in Educational Leadership at Grand Canyon University.

# Something to be told

In our not so distant past, this time of the year meant the end of the year and the arrival of a new one, official with the arrival of the summer rains. O'otham and Piipash hopes rose – soon there would be a lot of food! Ha:shan and its fruit would be ripe at the height of summer heat – it only needed to be gathered. Field crops which had been planted earlier would soon be ready. This abundance of food had to be shared, a time to come together and celebrate. Two Tohono O'odham women give their impressions of Ha:shan Baithag Mashat. Chona, who dictated her life story in the early 1930s said, "We counted the days. On the night before rain should come, there was lightening in the south. On the next day, came the dust storm, bearing the rain on its back. And then the rain!"

University of Arizona Regents' Professor, Dr. Ofelia Zepeda, captures an all too familiar summer moment with her poem Rain:

The Sun has moved down that way a bit. And yet it is so hot. All movement has almost stopped. A fly goes by so slowly. Everything has slowed down. My father is sitting there. His head is tilted hack and he's asleep. My sister is laying over there, asleep. The dog passed by, he is looking for shade.

Everything has slowed down. And yet the clouds have slowly settled in.

It's raining, it's raining!

My father jumps up "Run and cover my grain!"

"Run and get the clothes off the line!"

Everything is now moving and alive.

My sister is up,

The dog is up,

Everything is now moving and alive.

You can sense the change of pace rain brings to desert dwellers. Keep in mind, without summer rain, the earth might burn up. I know first foot how hot the ground can be for us

Another food which appears with the arrival of the heat is violog or mesquite beans. Violog was and is an early convenience snack; all you had to do was pick the long yellowish pod off the tree or pick one off the ground. They have a sweet taste and could be ground into flour, a drink, gruel or pudding. As children, whenever we found ourselves walking to lu'lu'u's, a cousin's or to the closest swimming hole, we chewed on them. A word to the wise, this food does produce gas, which is probably why we ate and slept outdoors during the summer. Leaving for town on a late summer afternoon, we made sure bedding was inside the house. Always keep an eye

Another food gathered from the desert was prickly pear or i:bhai. New growth leaves or pedals are sliced off the main body of the cactus. The thorns are carefully singed off, sliced and cooked, tasting like string beans. Seasoned with chilies, it is very tasty.

A true child of the desert is the tepary bean. The name comes from the Opata word tepar referring to the small white, brown or rust colored bean. The Tohono O'odham were once referred to as Papavi Kuadam or tepary bean eaters. This plant would give beans, in spite of the desert heat with little rain. Such a food would always be available.

In my early teen years, I helped my father in moving herds of cattle around District 5. He left me and another youngster to drive a small herd to a new field, while he drove over to the fresh field. Nearing the end of our trek, we let the herd take a short cut through a field full of brush – so I thought. The next thing I knew my father was yelling at us, frantically waving his hands, to get the cattle out of the weedy field. It was a field of tepary bean plants or bavi (buff). I hadn't taken the time to learn about the plant, I only like to eat the bean; to:tha (white), u'u's (speckled) and ba:vi (brown). So if the bean doesn't, don't pay too much attention to the temperature, keep an eye on the sky and make sure the clothes are off the line and your bedding is inside.

## To Native American Farmers or Ranchers or the heir of one who was denied a USDA farm loan or loan servicing between 1981 and late 1999

Some funds paid in settlement of Keepseagle v. Vilsack remain unclaimed and will be distributed in accordance with a process established by the Court. The case claimed that USDA discriminated against Native Americans who applied for or tried to apply for farm loans or loan servicing. The Court seeks input from class members about how the remaining funds should be distributed. Of the \$680 million paid to settle the case, approximately \$380 million remains. The Settlement Agreement approved by the Court directs that unclaimed funds be given to non-profit organizations to serve Native American farmers and ranchers

The deadline to file a claim has passed. There is no new claims process.

### Who is included?

The Class includes all Native American farmers and ranchers who:

- Farmed or ranched or attempted to do so between January 1, 1981 and November 24,
- Tried to get a farm loan or loan servicing from the USDA during that period; and · Complained about discrimination to the
- USDA either on their own or through a representative during the time period.

The class does not include individuals who:

- Experienced discrimination only between January 1 and November 23 1997: or
- Complained of discrimination only between July 1 and November 23, 1997.

### Proposed use of the Funds

There are several competing options for how to distribute the funds.

First, Plaintiffs propose to modify the Settlement Agreement, subject to Court approval, to distribute the funds as follows:

• \$342 million distributed by a Trust, overseen by Native American leaders, to non-profit groups to serve Native farmers & ranchers over a 20 year period.

\$38 million be distributed quickly to nonprofit organizations serving Native farmers & ranchers, identified by Class Counsel and approved by the Court

The Trust would make grants to organizations providing business assistance, agricultural education, technical support, or advocacy services to Native American farmers and ranchers, including those seeking to become farmers or ranchers, to support and promote their continued engagement in agriculture. The USDA has agreed with this proposal.

Second, Marilyn Keepseagle proposes to distribute all remaining funds as additional alone. The USDA opposes this proposal.

Third, other class members have asked to use the funds to pay claims that were initially denied or to permit new claims to be filed.

Fourth, the Choctaw Nation has argued that no changes should be made.


