## It's Your Constitution: Gila River Indian Community hosts constitutional convention

On Saturday, Aug. 29, a virtual constitutional convention was streamed live on Facebook and Gila River Broadcasting Corp. channels 19.1 and 29.1 to promote the Gila River Indian Community's upcoming Special Election, which will be held in conjunction with the General Election on Nov. 3.

Gila River Indian Community council voted and approved a resolution requesting that a Special Election be held on proposed amendments to the Constitution and Bylaws of the Gila River Indian Community. Three different articles in the constitution will be on the ballot: Article III – Membership, Article XI – Districts, Article XV – Powers of the Gila River Indian Community.

The proposed amendments are from the Tribal Constitution Reform Project who collected data from the Community on possible amendments to the Community's constitution.

The virtual convention brought together Community members to watch presentations and discussions from Gila River Indian Community's leadership and members on the proposed amendments on Facebook Live. Presenters answered questions sent in by email or commented "What we are talking about today is literally, who and what the Community stands for, and that's our Constitution."

during the live feed at the event's conclusion.

"What we are talking about today is literally, who and what the Community stands for, and that's our Constitution," said Gov. Stephen Roe Lewis who provided a welcome address to viewers. Sharing historical background of the Gila River Indian Community, its Constitution and Voting rights; "We can't take voting lightly," said Gov. Lewis who strongly urges Community members to vote. Lt. Gov. Robert Stone provided a prayer and also urged members to be informed and vote.

The Special Election requires at least 30 percent of registered voters to participate in order for the results to be valid or approximately 1,960 voters of the current 6,536 registered voters. Nadine Shelde, Tribal Elections Program, provided information on voter registration, although it is currently closed for the Sept. 15 Primary Election. Registration will resume Sept. 16 through Oct.

Community members are strongly encouraged to register and vote in both the General and Special Election. Applications can be requested and sent by mail. there are no online applications. In response to the pandemic it is strongly encouraged to vote by mail, notarization for absentee ballots are waived and must be signed by the voter. The Community will be offering "drive-thru" voting but if it is preferred, walk-in polling sites will also be available. Masks and physical distancing will be required. Anthony Gray, Culture Coordinator, Tribal Education Department, delivered historical presentation of the Community and its "transition from old to new ways," from the 1934 Indian Reorganization Act and the adoption of the initial constitution in 1936 as well as the current Constitution adopted in 1960. Gray's presentation an early included 1901 constitution from Santan, which was eventually vetoed by the Indian Agent at the time. Javier Ramos, Senior Counsel, Office of General Counsel, provided legal descriptions on the Special Election and the amendments up

for vote. Ramos said there will be separate ballots for the Special Election and shared examples of the questions on the ballot.

Anthony Newkirk, Gila River Urban Members Association, shared his perspective and opinions regarding Article III – Membership and the "Twenty-year Rule," which states that if a member who establishes residence off the reservation and remains away from the reservation, continuously for 20 years shall automatically forfeit membership. This article has never been enforced and its origin is unknown

"There are people that go to school, get a job elsewhere that probably aren't aware of this article," said Newkirk, who was born and raised in Chicago. Newkirk shared his background as an example of different situations

where a Community member does not reside in the Community. The Gila River Urban Members Association provides assistance to any Community member that resides off the reservation. For more information, you can visit their website gilariveruma. org, where you can also find copies of the Gila River Indian Community's constitution.

Keith McDonald from the Department of Land Use Planning and Zoning (LUPZ) presented the boundaries of the districts in the Community, with the main focus on District 6 and District 7 and Article XI that address the boundaries of Co-op. Maps are available from LUPZ upon request at (520) 562-6003.

## GRIC extends partial government closure as well as stay at home orders

Tribal Health Department released the Gila River Indian Community's latest COVID-19 Data Report on Sept. 2, which confirmed 1,961 positive cases and 21 deaths with 805 postive cases for GRIC members. Arizona has reached 203,953 positive case of COVID-19 as of Thursday, Sept. 3.

Due to the increase of COVID-19 cases, the Gila River Indian Community has extended partial closure of all government departments and offices, Executive Order No. 5 and the "Stay-at-Home" Executive Order No.6 until Oct. 4. Anyone living within the Community is ordered to continue to stay home unless they are conducting essential activities such as work, grocery shopping, outdoor physical activity, or caring for a family member, friend, or animal.

According to the Center for

Disease Control and Prevention, anyone can have mild to severe symptoms and those symptoms may appear 2-14 days after exposure to the virus. Symptoms may include fever or chills, cough, shortness of breath, fatigue, headache, muscle or body aches, nausea or vomiting, new loss of taste or smell. It is important to stay home if you are sick and monitor your symptoms.

Positive cases are high among those 44-years-old and younger, according to data reports by the Tribal Health Department. Continue to wash your hands often for at least 20 seconds or use hand sanitizer, maintain physical distance, wear a face mask when around others to help prevent the spread of the coronavirus.

Testing in the Community continues with more than 70,000 tests completed. Testing has been made available for anyone living or working in the Community.

## **EXECUTIVE ORDER NO. 6**

The Gila River Indian Community has extended Executive Order No.6 - Stay at Home Order to October 4, 2020. This order directs all individuals who live within the Community to stay home except to conduct essential activities.

Essential activities include going to work, grocery shopping, doctor visits, outside physical activity, or caring for a family member, friend or animal.

The Stay at Home Order will be strictly enforced by the Gila River Police department and can result in a citation.

## GRHC receives donation of recyclable bedside carts to assist patients

Gila River Health Care providers have a new convenient way to store supplies for COVID-19 patients thanks to two Northern Arizona University alumni, Taggart Neal and John Krueger, who donated 54 HEROCarts, which are now in use at the Hau'pal (Red Tail Hawk) Health Center.

Neal and Krueger represent TAGCarts with Neal as the CEO, and Krueger as the Advisor according to a GRHC press release, which also states that the carts are, "one time use, three-drawer, recyclable bedside carts filled with valuable [personal protective equipment] to keep nurses safe."

According to the TAGCarts website, the carts are designed for easy assembly and quick deployment. Krueger said when they are not in use, they can be stored flat and then propped up and ready to use in a short time.

"These lightweight yet durable multi-drawer carts on wheels are made out of corrugated paper board containing a high level of post-consumer waste (recycled content) and are filled with masks, gloves and other PPE," said Neal.

Neal said in field hospitals and alternative care units, such as the one at the Red Tail Hawk Health Center, there is a need for equipment that is not cost or storage prohibitive while treating patients.

In addition to eight counties in Arizona, HEROCarts have also been sent to the Navajo Nation, Sacramento, Stockton and Los Angeles, Calif., field hospitals.

"We are very grateful for GRHC, the state of Arizona, the Department of Health

Services, who received 250 of our HEROCart equipment and they disbursed them out to the counties," said Neal.

Neal and Krueger set up the HEROCarts along with GRHC staff at Hau'pal Health Center and loaded the carts with items to quickly treat and assist patients with COVID-19.

"Unprecedented times call for innovative solutions. The HEROCart is a perfect example of a scalable and deployable cart solution that addresses the need of nurses and clinicians treating our COVID-19 patients, improving safety and workflow," said Dr. Anthony Santiago, GRHC CEO, in a press release.


The carts are single patient use and can be easily put together in times when storage equipment is in short supply and storing medical items is limited.

"It's so important to have the supplies you need at hand and I

think these carts really enable our nurses to have everything at hand," said Michelle Kopec, GRHC Nurse.

She said the carts also serve as a place for patients to put

personal property in them and can function as a bed side stand, or can be positioned in areas where staff need to obtain supplies and reduce the risk of crosscontamination.



# **Business Interruption Grant Applications Now Available**

The Gila River Indian Community's Business Interruption Grant Program is available to businesses that have experienced a business interruption and that are solely owned by a Community member, or Community members.

If you are a Community member and your business had to close due to the COVID-19 public health emergency, or has experienced a 50%, or more, drop in gross receipts in any quarter in 2020, compared to the same quarter in 2019, you may be eligible to receive the grant.

The program is open to any Community-member-owned business, including farmers and ranchers, that can demonstrate a business interruption.

# A'AGA

#### Something to be told or talked about

This hot, socially distant summer will be remembered for a long time. In my house (Ñ ki ed) the only thing getting a constant workout is the remote. I need a reason to pry myself off the sofa. A visit to Hatch, New Mexico might just do it. The smell/aroma of roasting green chile is like perfume to many O'odham.

Working out the remote, I came across "Gordon Ramsey: Uncharted." The episode was about India, which has been a leading exporter of spices like pepper, chile, and cardamom. Indian Chef Shri Bala had Ramsev taste a very spicy Indian dish with a predictable result. Milk eased his pain. "Nature has given us more spices because of the climactic conditions. You're in the spice hub," said Chef Bala. Hot chile makes people sweat and cools us down. Probably why I'itoi put chiltepin plants on Baboquivari or Vav Giwulk and timed the summer rains to cool the earth or jeved. To earn money for school clothes in the 1960s, we went with our ba:b or ba'ba'a (maternal grandfather) to "chop cotton." He was over 60, but still led a "chopping crew." At lunch (12 noon, 105° plus), he would savor his sandwich with a bite of chile, and sip steaming coffee as sweat poured down his contented face.

Chile went to India from Native country. Grown for more than 8,000 years throughout Mexico, Central and South America, and right here in southwestern United

States, the chiltepin is the "mother of all peppers." It is the way-way-wayback grandmother of most cultivated chiles, and the only wild chile native to our country. The best known population is the Wild Chile Botanical preserve in the mountains a mile away from Tumacacori. Renowned ethnobotanist Gary Nabhan, who cofounded "Native Seeds/ SEARCH," wrote that a Tohono O'odham man told him Tumacacori means "place of the little round chiles." The O'odham word for chile is ko'okol. The root or base word is s-ko'ok which means hot/ spicy or hurt. Interestingly, the Greek word for chile also means a bite or a hurt. This taste for chile or ko'okol may go back all the way back to the Huhugam. As O'odham of the akimel. they raised a lot of maize, beans, and squash, some of which was traded with southern cousins whose items of trade were saguaro seeds and syrup, dried fruit, agave cakes and fibers, gourd seeds and wild chiltepin. (Olas ko'okol or round chili.)

Food/cultural appropriation or borrowing kind of boils down to, "What's mine is mine, what's yours is ours." The Indigenous Americas introduced new foods to the Old World such as chocolate, tobacco, tomatoes, chiles, corn, peanuts onions, and potatoes, to name a few. India-Indians made chiles "theirs," just as we O'otham have made some things "ours" that were not traditional-wheat or pilkan has been here less than 400 years. (In the

real old days, che-mait would have been corn for us until wheat arrived.) Traditions come and go, and evolve. The "food trinity" for Italians is a base mixture of onions, celery, and carrots. Louisiana's trinity is onions, celery and bell peppers. Some Asian

cultures begin with ginger, scallions, garlic. O'odham tables often have this trinity: chile stew, potato salad, and pinto beans. Spaniards introduced cattle and chickens and Germans get credit for introducing potato salad and most of the ingredients. Pinto beans

worked their way to us from Central and South America. Our traditional desert bean is the tepary/bawi or buf. It's just like us: brown, likes heat, requires little water, and is wrinkled (Well, some of us).

Our record-breaking heat wave has finally

ushered in the jegos, and GRIC has been experiencing power—no TV—oh no! Two solutions: grab some ko'okol' and go outside to cool off, or jump in the car and head to Hatch.

## Wellness Center continues workout programs during pandemic

Stay-at-home orders remain in effect in the Gila River Indian Community, but healthy activities are still available with online and virtual programs Tribal Recreation from and the Wellness Center. Community members can participate in several programs since the Wellness Center's location closed due to the COVID-19 pandemic.

Brandon Begay, Wellness Center Lead Fitness Instructor, said, "Going virtual is not a setback, I see it as a new initiative, and we all have a chance to get creative and contribute to these services. And what it comes down to is that we've all learned how to serve the Community a little better by thinking outside the box since the shutdown."

Partnerships collaborations among staff and other programs have been key in developing healthy outlets for GRIC members to reach fitness goals during the pandemic, which include pre-recorded activities, virtual runs, and live virtual workout sessions over the Zoom platform.

Begay mentioned that the workouts, designed for the comfort and privacy of the home, have increased

participation and attracted newcomers. Many firsttime participants find it assuring to have guided workouts provided to them that don't require weights or gym equipment. Begay said, "when a person doesn't have weights or dumbbells, we offer creative alternatives like milk jugs, packages of water, or anything for weight resistance to make it a little challenging."

Fit Kit Program

Wellness Center also launched their Fit Kit Workouts. Enrolled members of a federally recognized tribe can sign up for a specific fit kit, which includes workout equipment to utilize at home during the center's daily virtual workouts.

When the pandemic hit, gyms, including the Wellness Center, had to close. Begay said, "When we learned we would be sent home, we wanted to give our clients some equipment that they could use at home."

The staff took some time to consider center inventory and decided to distribute resistance bands. To date, the Wellness Center has distributed resistance bands, foam rollers, dumbbells, and yoga mats for clients to use during the virtual workouts throughout the week.

distribution opened Tuesday, Sept. 1, where clients could register to receive either a Stability Ball Kit or a 30 or 35-pound kettlebell kit. Stability balls are useful for abdominal core workouts, and kettlebells, similar to dumbbells, offer full bodyweight training for users.

past Like kit distributions, participants who receive a kit must commit to attending a Zoom workout with staff for proper safety instruction and demonstrations. Begay mentioned that they would build out programs for what he calls "Fit Kit Fridays" in the future. These classes will utilize all of the various equipment distributed throughout the year.

Begay hopes equipment will encourage clientele to stay active while social distancing. And even after the pandemic subsides and the center reopens, keeping virtual workouts as a future option is something they are considering.

Virtual Runs

Additionally, held Wellness Center virtual runs for Community members, allowing participants to track their runs (2 miles, 5k, etc.) to provide proof of completion. The virtual runs eliminate the risk of

in-person activities while Day: Darrell Whitman, qualifying runners program incentives.

The Wellness Center partnered with the Chief Azul Planning Committee for the Chief Azul Virtual Run and Walk. Begay said that the committee saw previous successful runs as a possibility to hold the run this year. The run occurred over a week, with runners tracking their 2 miles or 5k run to receive the commemorative Chief Azul Run T-shirt provided by the Chief Azul Planning Committee.

"For 2020 Chief Azul Day, members of the planning committee reached out to the Wellness Center to coordinate the virtual run for this year. The committee looked at the Wellness Center on past successes with virtual runs planned during the pandemic. We thank the Wellness Center for assisting the Committee and for a job well done.

Gov. Stephen Roe Lewis appeared on "Arizona Horizon," on Arizona PBS, Aug. 18, following the second day of the virtual Democratic National Convention, which was held in Milwaukee, Wis.

Gov. Lewis served as a delegate to the DNC and spoke with "Arizona Horizon" host Ted Simons about the Native American vote in the 2020 Presidential Election.

"It is truly an honor to be a delegate and also an elector as well for the Democratic Party, for the Joe Biden and Kamala Harris presidential ticket and for the state of Arizona as well," said Gov. Lewis.

He said as a tribal leader and delegate it was an honor to represent the Gila River Indian Community

and draw attention to the Arizona Native vote for the upcoming election.

"You Lewis said, have...the Navajo Nation in the northeastern part of Arizona, in the southern part you have the four O'otham tribes that makeup a large block of the vote in southern Arizona."

The Native American Caucus held a roundtable during the DNC on environmental justice in Indian Country. The roundtable covered subjects on environmental protection, the protection of tribally sacred sites and issues such as the border wall along the boundaries of the Tohono O'odham Nation and Mexico.

"We are hoping that tribes have a unique, critical voice, not only with the elections coming up but the Biden/Harris administration," said Gov. Lewis.

Lewis Gov. also discussed tribes working with the federal government and protecting tribal sovereignty. highlighted also the accomplishments of GRIC members who have contributed to the nation such as the late Rodney Lewis and Ira H. Hayes and other veterans who did not have the right to vote after serving in the U.S. military.

"[We] see ourselves as the first Americans, we see our right to vote as sacred and critical to our voice," said Gov. Lewis.




