# District 7 Hosts 159th Annual Mustering In Day Celebration

"Never Forgetting the First National Guard, Forever Honoring"

The 159th Annual Mustering In Day Celebration was held in District 7 Maricopa Colony on Saturday, Sept. 7.

The celebration again honors the O'otham and Pee Posh men who were mustered into service as what became known as the "First National Guard" of Arizona in 1865. This year's event theme "Never Forgetting The First Nation Guard, Forever Honoring."

Hundreds gathered on 83rd Avenue along the District 7 Multi-purpose building for the morning's parade. This year, entries represented several various tribal programs, enterprises, departments, color guards, O'otham and Pee Posh traditional dance groups, and Gov. Stephen Roe Lewis and Lt. Gov. Regina Antone.

Michael Marrietta, U.S. Army veteran, and Joey Whitman,

for the event's parade.

The day recognizes the U.S. Army, were grand marshals 88 O'otham men that formed

Company C and the 94 Pee Posh men that made up Company B. These men protected the Arizona

Territory in the 1860s while most of the U.S. military was occupied with the Civil War.

"Over 159 years ago when Arizona was a young state, they looked to our Pee Posh and O'otham warriors, precursors to our national guard and law enforcement," said Gov. Lewis.

He added, "This is an amazing, long-standing tradition that we have here in the Community. It's important to keep this history alive."

Following the parade and opening remarks, came an intermission with lunch provided to the first 500 people in attendance. Informational and departmental booths were also on site along with arts and crafts

Live entertainment continued throughout the day and into the night with traditional dancing featuring both O'otham singers and dancers and Pee Posh Bird singers and dancers.

# **DOI Hosts Roundtable on Increasing Capital Access for Tribal Communities**

On Sept. 3, Secretary Deb Haaland from the Department of the Interior (DOI) hosted a significant roundtable discussion with local tribal leaders, including Gov. Stephen Roe Lewis of the Gila River Indian Community.

The discussion focused on enhancing economic opportunities and investments in Native communities with representatives from financial, philanthropic, and non-profit sectors to discuss innovative approaches to expand economic development and investment in tribal communities. This meeting aimed to foster collaboration and address the unique challenges and potentials tribes face in today's economy.

Sec. Haaland opened the session by emphasizing the DOI's commitment to supporting tribal

sovereignty and economic development. The roundtable provided a platform for tribal leaders to share their insights, discuss best practices, and explore innovative solutions for fostering sustainable economic growth.

Gov. Lewis thanked Sec. Haaland for continuing her commitment to tribes and highlighted the Gila River Indian Community's partnership with the DOI through the innovative 105(l) lease program, which has funded the Community's newest police department building, Casa Blanca Community School, and Gila Crossing Community School.

Key topics included investment in infrastructure, renewable energy projects, and technology-driven initiatives. Leaders highlighted the importance of access to federal resources, streamlined regulatory processes, and



## GRIC Hosts Voter Registration Events and Debate Watch Party

In a vibrant show of civic engagement, the Gila River Indian Community continues to host a series of voter registration events throughout the Community, including a debate watch party on Sept. 10.

The initiative aims to empower Community members to participate actively in the electoral process and stay informed about critical issues impacting their lives.

"It's important for our community members to really educate yourselves because these issues, they affect everyday life in the Gila River Indian Community," said Gov. Lewis. "They effect the tribal sovereignty of our Community, our water rights, they effect whether we have the resources."

Voter registration events were held at various locations within the Community, providing members and residents with the resources and support needed to register to vote. In partnership with Pinal and Maricopa County, GRIC leadership and volunteers were on hand to assist attendees with the registration process, ensuring that everyone has the opportunity to make their voices heard in the upcoming elections.

On Sept. 10, Community members gathered at the Boys & Girls Club of Gila River—Sacaton Branch for the presidential debate watch party.

"I am so glad we had the opportunity to attend the presidential watch party," said Miss Gila River Susanna Osife. "It was insightful to hear the perspectives of both candidates as they shared their visions for the future. It's so important to educate ourselves on the issues that impact our tribal communities. May it be a step towards encouraging everyone to vote and making our voices heard!"

Gov. Lewis emphasized the importance of voting by highlighting the legacy of the late Peter Porter and Rudolph Johnson, both members of the Gila River Indian Community.

In 1928, Porter and Johnson filed suit after being denied the right to vote in Pinal County. The Arizona Supreme Court determined that tribal members were considered "persons under guardianship" and could not vote. 20 years later, the case was overturned when Fort McDowell Yavapai members Frank Harrison

and Harry Austin were also denied the right to vote.

By hosting these events, GRIC is promoting voter registration and cultivating an informed electorate prepared to engage with the democratic process. The Community's efforts reflect a broader commitment to enhancing civic participation and ensuring that tribal voices are front and center in the political arena.

"Here in Arizona, tribal members of the 22 tribal nations

didn't have the right to vote over a hundred years ago. It was two Community members, the late Peter Porter and Rudolph Johnson, that started the fight for our right to vote," said Gov. Lewis.



## Vashai Gakithag Mashath **Dry Grass Moon**


This month marks the beginning of fall with the occurrence of the Autumnal Equinox in a few days ahead. We observe the sun, as it slowly starts to travel further toward the south with each sunset. This month, the landscape dries out from the summer moisture and most summer crops are ready to be harvested.

In this article, we will relate about school items used in your daily school lessons. In your classrooms, you probably have some of these items in your desks and bookshelves. We will go through these items and give hints to what these O'otham words mean. The first is Ha-mashchamtham, this person gives you instruction every day during the school week. Hashpakud, this white liquid binds things together on a permanent basis. Thapial-ki'ishpakud, with this tool you cut things like paper and fabric. I-ma:sicthakud, these items come in a box and are of many shades.

Kosthal, this accessory you wear on your back to carry school items. Kuinthakud, with this tool, you measure things. Ohonakud, you probably have several of these items in your desk, some contain graphite lead and others different colors of ink. Thapial-si:shpakud, with this small object, temporarily holds paper sheets together. I-wa:nakuḍ, this object is made of rubber and is used to remove mistakes on paper. Ohon, you probably have a lot of these in your classroom on a shelf. E-mashchamtham, this person learns things and they can be of any age. Thapial, some of these items have lines, so you can write on them. Others are blank, so you can draw on them.

This month's crossword puzzle will test your memory of school items used in classrooms. We encourage you to learn and speak these O'otham words in your everyday lives. Speak with an Elder or Speaker and learn how to say the words. Words may be slightly different between villages. See if you can match the O'otham word with its English name in the crossword puzzle.





On August 9th, 2024, the Tribal Education Department hosted the 20th Annual Reservation-Wide Teacher In-Service at the Sheraton Grand at Wild Horse Pass. The well-attended event surpassed the past year's participation numbers with 537 attendees. Titled Reach for New Horizons, our goal was to provide teachers, administrators, and support staff with the tools and best practices for instructing Gila River Indian Community students while generating positive transformative experiences and fostering an understanding of GRIC Culture to maximize student success. Workshops provided by Tribal Education staff, GRIC Community school teachers, administrators, and others focused on the

empowerment of teachers in fostering self-esteem, self-reliance, and healthy classroom environments while cultivating positive relationships and mutual support amongst teachers, the schools, and the community.

The Keynote speaker, Dr. Amanda Cheromiah, Executive Director of the Center for the Futures of Native Peoples at Dickinson College in Carlisle, Pennsylvania, discussed the transformative power of knowing your history and embracing Indigenous ways of learning. She hosted multiple workshops encouraging educators to be "Changemakers" and provided community educators with strategies to enhance student engagement within the classroom and their communities.

All who attended this year's in-service were met with vendors from within and outside the community who provided resources that will assist their classrooms, students, families. There were team-building games, exciting raffle prizes, and a 20th-anniversary appreciation gift from the GRIC Tribal Education Department.

As the day ended, educators were complimentary of the content and focus of the Reach for New Horizons agenda for their schools, classrooms, students, and families. Ideas of empowerment, safety, health, early education, easing transitions for students, building a growth mindset, and taking a look back at historical methods of teaching.

United States to Washington D.C. advocating for an official American Indian Day from the White House.







## About the U.S. General Election

The U.S. General Election is an election where candidates running for Federal, State and Local Offices are elected. Every four years, major political parties nominate two candidates as their Presidential and Vice Presidential nominees. The nominees are placed on the ballot for the U.S. General Election in November.

This year, Arizona voters will vote for President, Vice President, Senator, Congressional Representatives and Arizona Senate and House Representatives.

Your vote is your chance to elect who you want as your representative. Sko Vote!

# **Voter Registration Information**

In order to participate in the 2024 U.S. General Election, you must be registered to vote in the state of Arizona. If you have registered during the U.S. Primary Election or during the Presidential Preference Election, you do not need to register again, you are still able to vote in the 2024 U.S. General Election.

\*Even if you voted in the Tribal Election, you must also register to vote in Arizona BEFORE you can vote for the President of the United States.

#### **Registration Requirements and Eligibility**

A person is qualified to register to vote in the State of Arizona if they meet the following requirements:

- Is a United States Citizen
- Will be 18 years old by the date of the next General Election (11/5/24)
- A resident of Arizona and the County listed on your registration
- Has not been convicted of treason or a felony, unless their civil rights have been restored; and
- Has not been found mentally incapacitated by a court.

## **How To Vote**

#### **Mail-In Ballot**

Voters can request to receive a mail-in ballot. Mail-in Ballots will be mailed out starting on October 9, the last day to request a mail-in ballot is October 25.

#### How do I turn in my mail-in ballot?

- A mail-in ballot can be mailed back, the last day to mail back your ballot is October 29, 2024.
- A mail-in ballot can be dropped off at an early in-person polling location.
- Your Ballot can be dropped off at a secure Ballot Drop Box.
- You can drop off your ballot in-person on Election Day on November 5.

However you decide to return your ballot, be sure you remember to SIGN your ballot and it is received by the County by 7 PM on Election Day (11/5).

#### **Early In-Person Voting**

You can choose to vote early before Election Day, visit your county website to find an early in-person polling location and be sure to have your valid ID ready when you vote.

#### **Election Day**

The U.S. General Election Day is on Tuesday, November 5, 2024.

Make a plan! The best way to ensure you are able to cast your vote is to have a plan.

- 1. Check your voter status: Make sure your name and address matches what it says on your ID
- 2. Check your valid ID: Make sure your name and address match what it says on your registration roll
- 3. Check your Polling Location: Make sure you are going to the right polling location to cast your vote

MARICOPA COUNTY RESIDENTS: If you are registered in Maricopa County, you can cast your ballot at any Polling Location in MARICOPA COUNTY ONLY.

#### **Voter Accessibility Assistance:**

Voters that have a disability or illness and require assistance to vote, such as needing a Large Print Ballot, Braille Ballot, Curbside Voting or a Ballot delivered to them, can reach out to



# What Should I Bring To Vote?

Arizona Voters are required to bring valid identification with them when they go to vote in-person on Election Day or in-person at an Early Polling Location. Your NAME and ADDRESS on your ID must "reasonably match" the information listed on your registration. Acceptable Identification must fall under 1 of the 3 lists below:

#### LIST 1: Photo ID with the Voter's Name and Address - 1 Required

- A valid Arizona Driver License
- A valid Arizona non-operating identification license
- A Tribal Enrollment Card or other form of Tribal Identification
- Any other valid United States federal, state, or local government-issued identification

#### LIST 2: A Non-Photo ID with the Voter's Name and Address - 2 Required

- A utility bill for electric, gas, water, solid waste, sewer, telephone, cell phone, internet, or cable/satellite television service dated within 90 days of the election;
- A bank or credit union statement dated within 90 days of the election;
- A valid Arizona vehicle registration;
- A valid Indian or Native American census card;
- A property tax statement for the voter's residence;
- A valid tribal enrollment card or other valid form of tribal identification;
- A valid Arizona vehicle insurance card;
- A valid Recorder's Certificate;
- Any mailing marked "Official Election Material," including a valid Arizona voter registration card; Any valid United States federal, state, or local government-issued identification.

\*Any List 2 document may be presented to a poll worker in electronic format, including on a smart phone or tablet.

#### LIST 3: The voter may present certain combinations of documents from Lists 1 and 2.

#### Voting with a GRIC Tribal ID or Certificate of Indian Blood (CIB)

The Fall/Winter 2024-2025 Dry-up Schedule is as follows:

Due to construction demands by P-MIP in Blackwater, on the Gila River Farms, and parts of Casa Blanca, and the desire of the growers, there will be no formal dry-up of the SCIP system this year.

While there will be no system-wide dry-up, the following areas will be dry, as previously agreed to by the affected growers:

A. SCIP Joint Works Canals 1. All growers in Blackwater served by Canals 2, 3 and 4 and sub-laterals, including the District growers served by Joints works canals 2,3, and 4, will be dry beginning Sunday morning, December 1, 2024, and continuing through sunday morning, February 9, 2025. No water will be available for these canals during this timeframe, as agreed to by all Community and District growers soserved. Full deliveries will resume on Monday, February 10, 2025. Growers will be able to take full flows up through Saturday evening November 30.




