Skyline Gila River Hosts FIRST Lego League Qualifier

To foster STEM (Science, Technology, Engineering, and Mathematics) education among Native American youth, Skyline Gila River hosted a FIRST (For Inspiration and Recognition of Science and Technology) Lego League (FLL) Qualifier robotics competition, tailored to Native American students on Dec. 14.

The event, a first for the school, featured 16 teams from in and around the Community including: Casa Blanca Community School, Skyline Gila River, St. Peter Indian Mission School, and the Boys & Girls Club of the Gila River Indian Community, all competing for a chance to advance to the state championship.

FLL is a global robotics program that introduces STEM to youth through hands-on learning with real-world problem solving.

Native American communities have historically been underrepresented in STEM fields, facing challenges such as limited access to resources and educational opportunities. Recognizing the need to address this gap, Skyline Gila River partnered with organizations like the I Rise Foundation and local STEM advocates.

The I Rise Foundation is a non-profit that provides STEM, athletic, and art programs to youth in Hispanic and Native American communities. Alberto Esparza, is the STEM teacher for Skyline Gila River and founder of the I Rise Foundation.

"I enjoy the staff, I enjoy the kids," said Esparza. "My goal is to teach, bring more STEM opportunities to Skyline, get more kids to consider engineering careers, because it starts here. First Lego League is the beginning of a career in engineering."

The FLL qualifier event brought together students, families, and volunteers. Each team was given a practice round and

St. Peter Indian Mission School takes 2nd place in robotics competition, heads to State Championship

In a proud moment for the students of St. Peter Indian Mission School, their robotics class secured second place at the FIRST Lego League (FLL) Qualifier, and advance to the state championship to be held on Jan. 18, at Arizona State University (ASU).

The FLL qualifier event was held at Skyline Gila River on Dec. 14, bringing together teams from across the Community and surrounding areas all eager to showcase their ingenuity and engineering prowess.

The team, named 'The Coconut Crabs,' is comprised of 15 students from St. Peter Indian Mission School in grades 5-8. They worked together to program robots and complete timed missions. They will be the only Native American team competing in the state championship and representing the Gila River Indian Community.

Fifth grader Benjamin Thomas, helped push the team to their win. "I was shy since we first got up there, I was shaking. I just stopped and then started doing the right things that I can, doing my best," said Thomas.

"He was the one that took us over the top. If it wasn't for Ben, then we'd probably be like third or fourth place," said JoEllen Kinnamon, the team's teacher. Thomas partnered with teammate Brenton Miles, eighth grade, to complete the missions.


"It was fun building the robots and the missions, and the coding was really great too," said Miles. "The challenges are getting the right measurements to get it to work and sometimes the wires are mixed up so it'll be in different ones."

Mikayla Lewis, eighth grade, shared that she didn't know what to expect when she first began robotics, "I was just wanting to try something out but I got more into it. I started to like it and like all my teammates, working with them was fun. We had our disagreements and our agreements but overall we're a good team and

I like robotics."

While earning second place was an incredible achievement, what also set the team apart was their innovative project: an underwater robot designed to study and preserve the deep ocean ecosystem and habitats. The innovation garnered widespread acclaim from judges and fellow competitors

Crystal Rodriguez, District 6, completed her first year of the two-year Pathways Mentorship program and was joined by GRRC leadership, staff, colleagues, family, and friends for a celebration on Dec. 19.

Rodriguez, has over 20 years of experience in gaming, with ten of those years in a management role. She's held numerous positions within the Gila River Gaming Enterprise (GRGE) and the Gila River Indian Community, including security, surveillance, gaming inspector, and internal auditor. She also holds a Master of Business Administration Degree in Management and a Bachelor

three competing rounds to preform autonomous robotic missions to be completed within minutes

"It is a best of three, so whatever their highest round of all three tournament rounds, that's the score that counts towards their game missions. But this regional tournament has three different components," said Matt Lewis with the I Rise Foundation.

"It has a research component, a game mission component, and a judge interview component. Each of those is scored a little bit differently and are valued in a different percentage way, so they cannot necessarily be the highest scorer on the game missions and still win this whole tournament if they do well on their research and their judge interview."

2025 O'otham Distances Near and Far

Ever wonder why O'otham point with their heads, and lips? For that possibility, we will have to take a giant leap backward in time, before modern conveniences. Imagine mom sitting under the va'tho weaving her basket. She instructed her daughter to bring more cattail for her weaving. "Him ko 'e bekai heg uḍvak vuḍa, thoakam amai." (Go bring another bundle of cattail and set it down there.) As she instructed her daughter, she did not want to release tension from her hands in weaving the basket to point, so she had used her head and lips to point. She most likely, held a splint of devil's claw in her mouth, in preparation for the next stitch.

If we examine the distance more closely, we

see that she said "amai" (there) away from her. If she wanted the bundle of cattail close to her would have said "i:ya" (close by). So, now we read that "i:ya" means (close by) and "amai" means (there), away from an O'otham at a distance. Another form of close is "mia" (near, next to). If mom had wanted the bundle of cattail right next to her, she would have instructed her daughter "Pt 'o ñmiabithk thaiwañ." (Set it down next to me.)

These are three examples of (there, close by and next to) and can still be spoken today. Now, we will come back forward to our present time. Did you ever have to 'dispatch' an intrusive 'critter' in your house? Back in the day, when we lived in our sandwich style home, it was not uncommon to find certain 'critters' inside our home. After we had dispatched a large scorpion, we were instructed by

mom, "M gu hu bekai heg nakshel koli thap!" (Take the scorpion over there to the fence!). We read that "gu hu" means (at a greater distance) away from a place. In that case "gu hu" was the distance from the house to the fence, which was about fifty-yards.

Another time, a ko'i (rattlesnake) had crawled behind our firewood box. Once again, we had dispatched ko'i, before we removed the carcass from the house. Grandma had instructed us, "Gam g hu 'ia'wua ko'i shai thap!" (Throw away the rattler way over there into the bushes!) In that case, we had left our yard entirely and took the dispatched ko'i into the desert at a great distance from our house. We read that "gam g hu" means far away. In that instance "gam g hu" meant a quarter-mile walk into the desert.

In this last example of

"at a great distance," one of our cousins had attended boarding school at Sherman near Riverside, California. The grownups often spoke of him and said, "Gaḍ hu mamshchamtham Wesley, Mondelai thap." (Far away, out of sight, Wesley is attending school in California). We have read about distances that separates an

O'otham from objects and persons from near, far, and far away in the distance out of sight. These are only a few examples of distances.

Practice saying these phrases in your everyday lives. Speak with an Elder or Speaker and see what other phrases for distances are possible. Phrases may be slightly different between the villages. The word search will challenge your memory of distances in O'otham.

RESIDENT NON-MEMBER REGISTRATION DEADLINE: JANUARY 31, 2025

The Community's Residency Ordinance requires all adults (18 years of age and older) who are not enrolled members of the Gila River Indian Community, but who reside within the boundaries of the Community to register their residency.

- All non-member residents 18 years of age and older must register their residency with the Enrollment Department by January 31st each year.
- Previously registered non-member residents will receive a renewal form by mail. All other non-member residents should contact the Enrollment Department.
- The Registration Form can be submitted in person at the Enrollment Office, a photo ID is required.
- Registration Forms can be submitted by email, fax or mail, notary is required.

A written comment shall state the name and mailing address of the person, shall be signed by the person, his agent or his attorney and shall clearly set forth reasons why the permit should or should not be issued. Grounds for comment are limited to whether the proposed permit meets the criteria for issuance prescribed in the GRIC Code: Title 17, Chapter 9 of the Air Quality Management Plan. Only persons who submit written comments may appeal a permit decision.




