

Signing for INFRA Grant completes funding for I-10 Expansion Project

On Jan. 17, Gila River Indian Community (GRIC) Governor Stephen Roe Lewis was joined by Jennifer Toth, Director for the Arizona Department of Transportation (ADOT) and Karla Petty, Division Administrator of the Arizona Division - Federal Highway Administration (FHWA), for the signing of the \$95 million Infrastructure for Rebuilding America (INFRA) grant awarded to the state in 2024 by the U.S. Department of Transportation.

The grant will be put towards the completion of the Interstate 10 Wild Horse Pass Corridor project: The 26-mile stretch of I-10, between Loop 202 (Santan/South Mountain Freeway) in south Phoenix and State Route 387, near Casa Grande. It remains a major commuter route and connects the Gila River Indian Community to surrounding cities and vital services.

For many years, this portion of the I-10 has been unreliable, unsafe, and has stretched the resources of the Community's first responders due to the high num-

ber of accidents and fatalities in what is often described as the "fatal funnel." The consistent strain on the Community's families, students, elders and employees led to an aggressive advocacy push by the Community to ensure funding is received and this stretch can be widened to match the roadways off the Community.

The INFRA grant was awarded to improve travel safety and conditions and will be used to widen the portion ten-mile portion of I-10 between Gas Line Road and State Route 387, improve the SR 387/SR 187/Pinal Avenue interchanges, and build a new interchange at Seed Farm Road. These new interchanges will be vital to ensure safe and adequate travel conditions.

"I am so proud of the Community's aggressive effort to ensure that this long-neglected stretch of the I-10 will be widened and improved to enhance the safety and reliability of this roadway for our members and all those who travel through the Community," said Gov. Lewis. "It not only will improve this vital stretch of highway in our State, it will improve the Community's access to it by building a new intersection at Seed Farm Road, connecting our government services directly to this vital transportation corridor." This project will widen and improve ten-miles of I-10 by adding one additional 12-foot lane in each direction and 12-foot shoulders, adding fiber conduit, installing concrete barrier between the eastbound and westbound I-10 to prevent crossover crashes, and installing a wrong way driving detection system. It also includes the following improves at interchanges and crossroads:

1.) Gasline Road: eliminate low clearance at the bridge. Improve crossroad by adding sidewalks and wider shoulders.

2.) Seed Farm Road: convert from crossroad to interchange. Improve crossroad by adding sidewalks and wider shoulders.

3.) Dirk Lay: remove low clearance bridge.

4.) SR 387/SR 187: reconfigure interchange, including adding sidewalks and widening the shoulders and reconfiguring the crossroad.

Community, Gov. Lewis Reassure Members Amid Immigration Enforcement Concerns

SACATON — Following unconfirmed reports of Arizona tribal members being questioned or detained by federal immigration officials, the Gila River Indian Community and Gov. Stephen Roe Lewis have issued guidance to reassure and assist members.

In a statement issued on Jan. 24, Gov. Lewis emphasized that no known cases of Gila River tribal tion, such as a tribal enrollment card, a Certificate of Degree of Indian Blood (CDIB), a valid Arizona driver's license, or a government-issued ID.

"Please be careful, and if traveling, ensure you have valid forms of identification to avoid any potential issues," said Lewis.

The Community is taking proactive measures to protect its members and uphold tribal sovereignty. GRIC departments, including the Police Department, are monitoring the situation closely to identify any potential risks or incidents that could affect members. Gov. Lewis noted that the Community is working to establish a direct dialogue with ICE to ensure that tribal membership IDs are recognized as proof of U.S. citizenship and that feder-

The guidance encourages members to remain calm, carry identification at all times, and report any encounters to the Community's Office of General Counsel at 520-562-9760. Gov. Lewis Highlights State-Tribal Collaboration at 30th Annual Legislative Day

PHOENIX - Governor Stephen Roe Lewis of the Gila River Indian Community gave a keynote speech to hundreds of tribal members and Arizona legislators on Jan. 15 at the Arizona Capitol during the 30th Annual Indian Nations and Tribes Legislative Day. The event, themed "Embracing Our Past, Celebrating Our Future," marked three decades of collaboration between Arizona's tribal nations and state government. In his remarks to a joint session of the Legislature, Gov. Lewis highlighted the importance of state-tribal partnerships and their role in addressing critical issues. "Every tribe here has examples of how we have worked together with the state to craft solutions that

serve all the people of Arizona," Lewis said. He pointed to the 2021 tribal gaming compact as a prime example of successful collaboration, describing it as "a common approach to limited, exclusive tribal gaming that benefits the entire state."

Lewis also underscored the significance of

infrastructure improvements achieved through partnerships, including the widening of Interstate 10 through the Gila River Indian Community. "This critical project got off the ground because of close partnerships with state and federal officials," he said.

GRIC Voter Turnout Showed Mixed Progress in 2024

The Gila River Indian Community (GRIC) saw a voter turnout of 49% for the 2024 election, according to data provided by Arizona State University's Indian Legal Clinic. The result from the Nov. 5th election was slightly lower than the Community's 50% turnout in 2020, but better than the 47% turnout in 2016. While the numbers show steady participation during presidential elections, GRIC still trailed several other Arizona tribes, including the Navajo Nation, which had a 59.67% turnout, and the Ak-Chin Indian Community, which reached 62%.

between Pinal County and Maricopa County. The Pinal County precincts are: Blackwater 60, Sacaton 29, San Tan 61 and Casa Blanca 62. The Maricopa County locations are Komatke – 425 and Pee-Posh – 629.

Statewide, slightly below 80% of all registered voters went to the polls this year, about the same as in 2020.

A closer look at GRIC's turnout in 2024 reveals differences among the community's voting districts:

• Blackwater: 52% turnout (459 ballots cast out of 881 registered voters)

• Maricopa Colony: 52% turnout (230 ballots cast out of 444 registered voters)

• Sacaton: 50% turnout (537

ballots cast out of 1,133 registered voters)

• Santan: 49% turnout (487 ballots cast out of 1,000 registered voters)

• Casa Blanca: 47% turnout (504 ballots cast out of 1,071 registered voters)

• Komatke: 43% turnout (385 ballots cast out of 698 registered voters)

Blackwater and Maricopa Colony had the highest turnout, with 52% of registered voters participating. Meanwhile, Komatke recorded the lowest turnout at 43%. The Indian Legal Clinic analysis reports that 5,456 members who live within the Community's borders have registered to vote with 2,648 ballots cast.

"In very close elections, tribal voter turnout can be a real difference maker," said Gov. Stephen Roe Lewis. "Because the Community has many more younger voters than some of our Arizona sister tribes, it can be difficult to drive higher turnout. No matter the challenges, I'm proud of the thousands of Community members who took the time to vote in 2024."

GRIC leaders and the Community Public Affairs Office (CPAO) worked together to engage voters ahead of the 2024 election. Efforts included voter registration drives, a voter education guide, and a "Get Out the Vote" rally featuring Arizona leaders like Gov. Katie Hobbs and Attorney General Kris Mayes. These initiatives aimed to energize registered voters and emphasize the importance of the Native vote in a critical swing state.

Ultimately, Donald Trump won the state of Arizona by a margin of about 187,000 votes.

Voter turnout varied significantly among different Arizona tribes. Both the Tohono O'odham Nation and Kaibab Paiute tribes also showed high participation rates, each with a 63% turnout. The Ak-Chin tribe followed closely with a 62% turnout. The Pascua Yaqui tribe had a turnout of 54%, while Fort McDowell, San Carlos, and White Mountain each had a turnout of 53%. The Salt River Pima Maricopa Indian Community had a 52% turnout, and the Gila River Indian Community had a 49% turnout. Lower turnout rates were observed in the Hualapai and Havasupai tribes, with 39% and 37% respectively.

Gov. Lewis, who has testified before Congress regarding the challenges faced by Native voters, cited multiple obstacles that can drive down voter turnout, including a lack of traditional street addresses, which complicates voter registration, and the inaccessibility of many polling places.

"Despite the barriers we face, voting is a powerful act of sovereignty and self-determination," said Gov. Lewis. "Every vote cast by a tribal member strengthens our fight for equity, justice, and resources our Community and Indian Country deserves."

reminded of their legal rights, including the right to remain silent and to request an attorney if detained.

Gov. Lewis assured the Community that these measures are precautionary and that there is no evidence of any GRIC members being impacted so far.

"We are doing everything possible to gather accurate information and ensure that the rights of our members are respected," he said. The Governor urged members to remain calm as the Community continues to monitor developments

WHAT TO DO IF MISTAKENLY STOPPED FOR QUESTIONING BY FEDERAL AUTHORITIES FOR IMMIGRATION STATUS

- · Remain calm and polite.
- Have your Tribal ID or other ID on you if at all possible to confirm your U.S. citizenship.
- Provide accurate and truthful information in response to any questions posed.
- Remember the details of your encounter and report them to the Office of General Counsel as soon after the encounter as possible by calling the following number: 520-562-9760
- Ask for the identification of the immigration or other law enforcement personnel who have stopped you, and take note of the person's name, agency, badge number, and contact

Other Arizona tribal nations have taken similar steps since mid-January. Navajo Nation President Buu Nygren and SRPMIC President Martin Harvier both released statements on Jan. 24th calling on tribal members to carry state-issued identification, such as a driver's license, other picture identification, or their Certificate of Indian blood at all times.

The Community is committed to keeping all members informed and safe during this uncertain time. Updates will be provided as more information becomes available. For now, members are encouraged to follow the recommended precautions and reach out to Community resources if they encounter any issues. information if possible, and include this information in any report you provide to OGC.

- While it is not likely that you will be arrested after being stopped, if you are, you have federal rights that must be respected, including the right to be silent in response to any questions after you are arrested, but you need to tell them that you are exercising that right.
- You also have the right to a lawyer. If you are arrested, you can contact the Office of Defense Services for assistance in finding representation to assist you at the following number: 520-562-5700
- We do not expect any federal officials to come onto the Reservation to enforce immigration laws at this point, and will be reaching out to them in the coming days to confirm that expectation and to establish procedures for cooperation with our tribal police to ensure our members and our sovereignty is respected. In the meantime, if you do observe any federal officials on Reservation seeking to enforce the federal immigration laws, please report this immediately to OGC at the number above.
- Finally, we urge all members to remain calm in this time of uncertainty. There are many inaccurate reports and rumors that are currently circulating and we are doing our best to ensure that we have accurate facts. We will keep members informed of all developments as we learn more.

Where Are Your Discharge Papers?

Where is your DD214? The DD214 is a document that is presented to the Veteran upon discharge from the military. It gives insight into the active duty military time. It has the date the individual started basic training and the date of discharge. It contains a lot of other significant information!

The DD214 is needed to apply for benefits (including disability benefits) through the VA. Providing this document decreases the time it takes to process claims. It takes extra time for claims to process if the VA has to request and wait to receive the document. The VA will not award any benefits without this verification.

In order to receive Military Honors at burial, the DD214 has to be presented and reviewed in advance before Honors will be planned. Certain types of discharges can make a Veteran ineligible for military honors. We will gladly answer any questions you may have.

The VA has 2 possible benefits for Surviving spouses. It is possible to not be eligible for either one. In filing a claim, the surviving spouse has to present the discharge document when filing if the Veteran was not receiving a monthly payment from the VA.

Gila River Veteran and Family Services Office is accredited with the VA. We are able to assist with filing claims and explaining benefits. We can assist with ordering a DD214 if you don't have one. It takes approximately one month to receive from the time it is ordered. It must be ordered by the Next of Kin or our office can order it if the discharge was more than 62 years ago. Again, this process takes about a month. Being accredited with the VA does NOT give automatic access to random DD214s. We do not have authorization to access every discharge document held by the National Ar-

l chive.

If the Veteran is deceased, the discharge document can be ordered by the Next of Kin. Next of Kin includes parents, spouse, siblings and children. If they are deceased, Next of Kin includes grandchildren.

If the DD214 is needed for an emergency like for burial, then the funeral home can order it quickly.

To avoid the long processing time for ordering the document, you may bring a copy of your discharge document to our office. We will keep the copy on file to assist you and/or your family at the time of need. Many civilians don't know what the DD214 looks like. You may know where it's kept, but does your family know where to find it when and if they need it?



On Jan 10, Education Forward Arizona hosted its annual Leadership Symposium for scholars, held in Phoenix. This Symposium allowed students to connect, under the theme "From Dreams to Degrees."

A good portion of the attendees were representing Native American Communities, making up a little less than 100 students of the 300 attending.

Ryan Moreno is one O'odham student of the Community's sister tribe, Tohono O'odham Nation. "This is my second year coming to this event, it's encouraging to see organizations willing to help Native American students complete their college goals," said Moreno. The symposium included various workshops,

networking events, and keynote opportunities designed to help students gain insight into a range of organizations. The event was widely regarded as a success for students statewide, particularly those representing Native American communities

Now some good news for students in the upcoming year, two scholarships applications will be available. First is the Freeport-McMoRan Native American College Scholarship. It's open Feb.1, 2025 and closes on May 1, 2025. Enrolled members of the Gila River Indian Community are eligible to apply.

A second scholarship will be The American Indi-

He called for similar cooperation to address other infrastructure challenges, such as improving State Route 347.

Chairwoman Amelia Flores of the Colorado River Indian Tribes and President Sandra Pattea of the Fort McDowell Yavapai Nation also addressed the gathering. Both leaders shared perspectives on issues affecting tribal communities, including water management, economic development, and the need for continued dialogue with state officials.

The day's events, organized by the Arizona Governor's Office on Tribal Relations, also highlighted cultural traditions and the involvement of tribal youth. Students from Gila Crossing Community School recited the Pledge of Allegiance in both O'otham and English during the opening ceremony. Jr. Miss Gila River, Shayla Davis, also attended the resources fair on the Senate Lawn.


Gov. Lewis used his speech to focus attention on two key issues: Arizona's water crisis and the epidemic of missing and murdered Indigenous people. On water management, he stressed the need for science-based solutions and long-term planning. "Arizona's future depends on our ability to meet this challenge together," Lewis said, advocating for policies that balance conservation with sustainable use of water resources.

Addressing the troubling number of missing Indigenous women in Arizona, Lewis called for action. "Arizona ranks third nationally in cases of missing Indigenous women," he said. He urged lawmakers to support a proposed "Amber Alert"-style system to coordinate tribal, state, and federal responses to missing Indigenous persons.

"This is an opportunity for action, and I hope you will support this effort," said the Governor.

The Legislative Day, held annually, provides a forum for tribal and state leaders to honor the contributions of Indigenous communities and work toward shared goals. Over the past 30 years, it has become a cornerstone of state-tribal relations in Arizona.

"Together," said Gov. Lewis, "we can build on the progress of the past 30 years to address the challenges and opportunities of the future."





The lack of an adequate domestic, commercial fuel supply could impede both reactor demonstrations and the development of future advanced reactor technologies.
